

2018 EXPO Rules & Regs

The rules governing the TowneBank Outer Banks Marathon Race Expo exist between the Exhibitor named on the contract and Outer Banks Sporting Events (OBSE).

Use of Exhibit Space

Exhibitor booths are solely for the display of the Exhibitor's products and services offered for sale or information. Exhibitors are not permitted to sublet any portion of their space. All exhibits must not obstruct the view or interfere with exhibits of others. No exhibit material may extend beyond the boundaries of the exhibit space.

Booth Assignments

Race Expo booth space will be made when payment is received and is on a first come, first serve basis. If none of the spaces requested are available, OBSE may allocate another space. Receipt of the attached Exhibitor Application does not guarantee space in the Race Expo. OBSE reserves the right to refuse applications deemed inappropriate for the Expo. You will be emailed your confirmed booth space(s).

Relocation of Exhibits

OBSE reserves the right to alter locations as shown on official floor plan, if deemed advisable. The actual occupancy of the Exhibitor is of the essence hereof and, in the event the Exhibitor does not occupy the space by 11:30am on Friday, November 10th, OBSE is authorized to occupy or cause said space to be occupied in such manner as it may deem best for the interest of the Exhibition without in any way releasing the Exhibitor from any liability hereunder.

Care of Space

It is the Exhibitor's responsibility to utilize and return booth space in the same condition it was when taken over. In case of damage, the Exhibitor will pay such claims as are necessary to restore the space to its original condition.

Trash & Recycling

Exhibitors will be responsible for maintaining a clean booth area. We ask that all trash and recycling items be dis-posed of by the vendor into designated receptacles.

Food Service

In order to distribute prepared on-site food or beverage of any kind you must obtain permission from OBSE and a Temporary Food Service Permit from the Dare County Health Department by calling 252-475-5080.

Building Rules and Town Ordinances

The Exhibitor will obey all rules and ordinances as prescribed by the First Flight Middle School and the Town of Kill Devil Hills now in existence or may hereafter be made and will abide by the rules and regulations of all other departments whose duties embrace such exhibits.

Limitations of Liability

The Exhibitor agrees to make no claim for any reason whatsoever against OBSE and/or Dare County Youth Center for loss, theft, damage of destruction of goods, or for any injury to himself or employees while in the show. Exhibitors agree to indemnify OBSE/FIRST FLIGHT MIDDLE SCHOOL against or hold them harmless for any blame rising out of the Exhibitor's participation in the TowneBank Outer Banks Marathon Race EXPO.

Dismantling of Exhibits

Exhibitors may not begin dismantling or packing material until show close Saturday, November 10, 2018.

Cancellations

A cancellation must be emailed or made in writing before October 1st, 2018. Any company that gives notification by September 30th will receive a 50% refund. No refunds will be given on or after October 1st.
